## WAIVER, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

**PLEASE READ CAREFULLY**

**Warning: By signing this agreement, you give up the right to sue for any injury or damages howsoever caused.**

To: **Affinity Stables, Emily Taylor Legacy Project and CASA**

(hereinafter, referred to collectively as "The Company"; and employees, representatives, officers and agents; hereinafter referred to collectively as "The Company's Employees").

Hereby sign this agreement on behalf of myself, my personal representatives, heirs and assigns.

1. I agree as a precondition to my participation in a riding lesson, trail ride, team roping and/or penning, and all recreational riding activities organized by or occurring on the premises of "The Company" and/or conducted by "The Company" and/or "The Company's Employees", and in further considerations of the "The Company" allowing me to do so, to be strictly bound by the terms of this Waiver, Assumption of Risk and Indemnity Agreement (hereinafter referred to as "This Agreement").
2. I acknowledge that riding lessons, trail rides, team roping and/or penning, and all recreational riding activities involve inherent risks that may cause serious injury and possibly death to participants. I further recognize that back country trail, horse and wagon/sleigh/carriage rides involve additional risks and dangers.
3. I fully understand the risks and dangers associated with my participation in this riding lesson, wagon/sleigh/carriage, trail ride or team roping/penning and accept same entirely at my own risk.
4. I hereby waive any and all claims which I may have against "The Company" and "The Company's Employees" and release "The Company" and employees from all liability for injury, death, property damage or any other loss sustained by me as a result of my participation in this riding lesson, trail ride, team roping/penning or other riding activities due to any cause whatsoever including without limitations, negligence on the part of "The Company" or "The Company's Employees". I further agree to indemnify "The Company" and "The Company's Employees" for any and all legal fees (on a solicitor and his own client basis) or costs which may be incurred in defending any lawsuit or claim I may bring against them.
5. I appreciate that This Agreement applies whether "The Company" is at fault or not and it limits the liability of "The Company's Employees" to the same extent as it limits the liability of "The Company" even though "The Company's Employees" are not formal parties to This Agreement. I understand that "The Company", in securing execution of This Agreement by myself, is acting as agent or trustee on behalf of or for the benefit of "The Company's Employees", who shall to this extent be or be deemed to be parties to This Agreement.
6. All minors (horse back riders under 18 years of age) are required to wear protective head gear in the form of a high impact helmet. Footwear appropriate for riding is required by all persons, regardless of age.

I have read and understand this agreement. I understand that this document contains a promise not to sue "The Company" or "The Company's Employees" and a release and indemnity for all claims.
